

## FAMILY ENGAGEMENT IN EDUCATION

WHEREAS, Research has shown that the most significant predictor of a student's academic success is parental engagement in the student's education, regardless of socioeconomic status, ethnic/racial background, or parents' educational level<sup>1</sup>; and

WHEREAS, When parents and educators and members of the community cooperate to encourage learning, research indicates children have higher success rates that will continue beyond graduation<sup>2</sup>; and

WHEREAS, The strongest predictors of parent engagement at school and at home are 1) specific school programs that guide parents to help student succeed and 2) teacher practices that encourage parent involvement in the education process<sup>3,4</sup>; and

WHEREAS, Schools that foster relationships between parents and educators have improved teacher morale and higher ratings of teachers by parents<sup>5</sup>; and

WHEREAS, When parents are involved, students exhibit more positive attitudes, as well as decreased alcohol use, violence, and antisocial behavior<sup>6</sup>; and

WHEREAS, The second statement in the Mission of Utah PTA is to "encourage positive involvement in all facets of a child's life"<sup>7</sup>; now, therefore, be it

Resolved, That Utah PTA actively seek or develop and promote programs that assist parents in developing the skills they need to raise and protect their children; and be it further

Resolved, That Utah PTA and its constituent bodies provide opportunities for parents to feel welcome at their children's schools and to interact positively with teachers and other school personnel; and be it further

Resolved, That Utah PTA promote the use of programs and tools, such as the Family Education Plan, to guide parent, alongside their children, in forming plans for their children's education; and be it further

Resolved, That Utah PTA support policies of the State Board of Education and local school districts that result in practices that encourage parental engagement in education; and be it further

Resolved, That Utah PTA and its constituent bodies encourage partnerships between community members and public schools that will champion parental engagement in education.
